

On January 3-6 of 1985, in the Colonia Dignidad area, the Chacabuco Regiment intensified its military patrols in the outside perimeter of these facilities. MOTIVE: Infiltration of an Israeli Intelligence Unit which intended to seize from Colonia Dignidad a person by the name of Mengele who had arrived by air from Recife (Brazil). On January 4 a foreign citizen was found at the Rio Sauce ford (near the point where it meets the Nuble River), with the following physical description: height 1.78 m., wide forehead, scarce hair, semi-athletic build, slavic type DOCUMENTS: U.S. passport. NAME: Boris W. (this is all I remember seeing before the officer in charge snatched it from me), documents from a University in the United States, a map of the region with certain marks on it. PERSONAL EFFECTS: Knapsack, individual tent, mountain cooker, camping knife, dark brown parka, reinforced shoes, compass, and binoculars. This person arrived at the cable ferry which crosses the El Sauce river. The caretaker, who lives nearby and is an employee of Colonia Dignidad, was the one who informed us of this person's presence. Also, Carabineros of the El Roble police station registered his passage. This person was delivered to the AUTHORITIES of Colonia Dignidad headed by persons by the names of SMIHT, P. SHAEFER AND STRAUSS. (It is appropriate to mention that

Later on we found out that this person, after being questioned savagely, was made to kneel on the ground and was murdered with a shot in the nape of his neck. This execution was carried out only by the Germans who took advantage of the absence of the Chilean authorities. Two United States Consular Delegations went out to search for this U.S. Citizen.

Major Nekerman of our Army was in charge of Interior

The second delegation headed by a woman of Latin origin was more persevering, resulting in the disappearance of the Carabineros at the El Roble police station, and of their log book where the passage of this person had been registered. At the same time, all military personnel was withdrawn from the area. It is appropriate to mention that members of the Army did not take part in this criminal action.

BACKGROUND: At the beginning of the seventies, the excellent intelligence officer (Colonel) Manuel Contreras prepared several dossiers on members of the judiciary power, proving many cases of corruption and undue appropriation of goods or properties to benefit friends or family members, perpetrated by present members of some Courts of Appeals and the Supreme Court who still remain in office. These documents, perhaps due to some miracle, are also held by the Germans at Colonia Dignidad.
