Thank you for your letter of September 18 written on behalf of your constituent, Gary Mullen. Mr. Mullen asked for updated information on the ongoing Chilean government investigation into the fate of American citizen Boris Weisfeiler, who disappeared in Chile in 1985.

The case has been under the active supervision of investigating magistrate, Judge Juan Guzman, since January 2001. Judge Guzman has searched the premises and files of the settlement in southern Chile formerly known as Colonia Dignidad on more than one occasion for any indication that Mr. Weisfeiler might be there or have been detained there in the past, as was reported by some sources. So far, we understand he has found no evidence Mr. Weisfeiler is, or ever was, present at Colonia Dignidad. More recently Judge Guzman led an expedition to the nearly inaccessible site along the banks of the Nuble River where Mr. Weisfeiler disappeared.

To assist in the investigation, the U.S. Government has provided Judge Guzman with documents pertaining to the case. The Embassy has been in contact with the Judge and monitors developments in the case and is ready to support him further should the need arise.

We trust that this information proves useful to you in responding to your constituent. If you have additional questions or believe that we may be of further assistance in this or any other matter, please do not hesitate to contact us.
